Across the four themes, women and girls are the point of entry of all activities, hence, collaboration with grass root organizations and local community leaders is maintained as well as creating linkages with national institutions and formal bodies providing opportunities for networking to influence change and induce peace and development

## **ALMANAR's GOAL**

### **The Goal of Almanar Work: Durable Solutions:**

Durable solutions are achieved when disagreements are no longer solved through violence, basic human rights are respected, governance is settled and broadly accountable, and communities are relatively self-reliant.

Durable solutions are the building blocks for peace and stability and for economic, social and political development. Programs that lay foundations for durable solutions address structural problems more than traditional relief solutions do, helping people to change their societies rather than merely fulfill their immediate needs.

Almanar cannot and should not impose solutions; instead, we want to empower people to define, clarify and bring life to their own answers. Without this kind of ownership, Almanar programs may leave people vulnerable to renewed cycles of violence, human rights abuse and forced displacement.

Working toward durable solutions is a long-term process. The societies with which Almanar works typically suffer decades of conflict. Their attainment of durable solutions may take generations. We want all Almanar activities to work toward this goal. Almanar aspires to accompany societies as they find and pursue durable solutions. At that point, we at Almanar would be able to say that our role has ended.

The Program Framework provides us with a roadmap for this journey.

**Almanar Aims: Saving Lives and working for healthy future, Strengthening Institutions and Promoting Social Cohesion**

How does Almanar best work with war-affected communities and societies to find and pursue durable solutions? Where do we concentrate our commitment, energy, and resources? The Program Framework answers these questions with its three key aims.

Almanar pursues durable solutions by *Saving Lives, Strengthening Institutions, and Promoting Social Cohesion*.

**Saving Lives:** Almanar works with displaced people and others affected by conflict to sustain their survival with dignity and safety. Perhaps most obvious in a crisis situation, saving lives refers not only to preventing mortality, but also to ensuring people's basic rights—that individuals are recognized by law and have access to services such as nutrition, protection, capacity building and economic development in all situations.

Helping people survive with dignity is the first step to durable solutions. But conflict can recur unless its root causes are addressed. Aware that conflict has many causes, Almanar believes that communities can do a great deal to reduce inequities that are at the core of the problem.

**Strengthening Institutions.** Institutions are defined as organizations, groups and associations. They structure interaction in areas of interest—in government, law, public service, civil society and commerce—and can be related to both causes and consequences of conflict. Transparent, inclusive, accountable and participatory institutions (those that involve citizens in decision making) are the foundation for a well-functioning society where people manage their differences without resorting to violence.

Therefore, the second aim of Almanar programs is to help war-affected societies strengthen institutions. But society's institutions do not exist in a vacuum. They cannot function properly without the trust of the citizens they serve.

**Promoting and enhancing Social Cohesion.** War-affected societies cannot move away from conflict if trust does not exist among the people themselves. Social cohesion refers to common bonds that promote tolerance, pluralism and inclusion. It is the trust between different people and between citizens and their institutions that makes for good governance. Social cohesion is one of the first things damaged by conflict. It is also one of the most difficult to repair. Nevertheless, it is a vital building block for war-affected communities working toward sustainable peace and development.

### **ALMANAR's METHODOLOGY:**

The Program Framework reaffirms the value of Almanar's multi-sector approach, as it provides the rationale for addressing people's needs holistically and offers a toolkit for doing so. This toolkit consists of Almanar programs and programming principles.

### **The Programs is divided into three categories:**

- **Basic Services Programs:**

Seek to improve people's quality of life and the conditions in which they live, as well as enhance the dignity by which they do so. Examples include treatment of acute malnutrition, feeding centers, health and support by paying school fees and providing kits to children of inmate women.

- **Economic Development Programs:**

Seek to give people access the resources they need to improve their standard of life, livelihood and sense of well-being at present and for the future. Examples include income generation, agricultural development, vocational training, and women co-ops.

- **Protection, Peace Building & Governance Programs:**

Seek to empower people to engage and interact with decision makers, to make collective decisions about their futures, and to claim their basic rights as recognized by international and national law, as well as help governing bodies become more inclusive. Examples include war affect population protection, civil society and community development, provision of Reintegration Services to Women Associated with Armed Forces / Groups (WAAF/G), reintegration of imamate women in their communities, alleviation of gender-based violence, and support of rule of law and good governance.

#### **Cross Cutting Interventions:**

- Gender
- HIV/AIDS
- Environment

#### **Almanar's programming principles:**

Five programming principles guide Almanar's work in all settings and across all program areas. The principles are crucial complements to the program sectors because, in many ways, how we work is as important as what we accomplish. Consequently, the methods we use must be participatory, based on real partnership, and reflective of people's rights and the contexts in which they live.

All activities will consider ***Do No Harm*** and Accountability to Affected Population principles and Conflict Issues

Almanar's programming principles include:

- Protecting and Promoting Rights;
- Participation;

- Capacity Building;
- Partnership;
- Holistic / Integrated Programming.

These are described in more detail in the following:

### **Protection and Promotion of Rights:**

Almanar recognizes that all people have basic rights. These rights are embodied in international laws, international humanitarian laws, IDPs laws and the Universal Declaration of Human Rights.

Almanar's commitment to protecting and promoting rights is fundamental to our programming. Rather than offering charity to people in need, Almanar strives to help people realize their rights as entitled by law. This translates into programming that considers how aid affects social and economic conditions and the relationships between displaced and host communities.

Specifically, we pursue this principle in four ways:

- ***Ensuring equal access to services and programs.***

In order that our programs are available and accessible to all community members, we need to be aware of the risks to and vulnerabilities of different groups within a community (e.g., women and children). By working with these groups in planning, implementation and evaluation of our programs, we can reduce barriers to securing basic rights.

- ***Strengthening people's capacity to claim and advocate for their rights.***

Informing people of their rights is only one step in ensuring fulfillment of rights. Community members and displaced people also need to know how to claim those rights.

- ***Supporting the capacity of authorities to fulfill rights.***

In order to uphold their responsibility to protect rights, government agencies require the capacity to do so. Our programs should not substitute for the state but reinforce its positive role and promote its willingness to provide protection.

- ***Accountability to the individuals and communities we serve.***

A range of actors, including government, community leaders, CBOs, Women Co-ops, other NGOs and Almanar's staff are accountable to community members we work with. This approach reaffirms Almanar's commitment to the prevention of the abuse and exploitation of affected communities.

### **Participation**

Participation is defined as the real involvement of communities in all aspects of Almanar programs. We mean people with whom we work directly, their wider communities, and local community-based or nongovernmental partners (CO-ops, CBOs or NGOs). Participation refers to sharing in discussion and decision-making. Participatory methods should be built into every program in order to guarantee peoples' meaningful involvement during project assessment, design, implementation, monitoring and evaluation.

**Why is participation important?** Like capacity building, it is included in Almanar's principles to gear everything we do toward community ownership. Our vision is to serve more as technical advisers than direct implementers. Making this a reality will require engaging people directly throughout all stages of Almanar's work: planning, implementing, monitoring and evaluation. Because people are ultimately responsible for their own destinies, they must be active participants in Almanar's work as opposed to being passive recipients of our assistance.

Passing on ownership of Almanar programs is a gradual process for which specific tools are available. Although it may not be possible to use these tools in every situation, participation should be pursued to the greatest degree achievable in each context.

### **Capacity Building**

Also called capacity development or capacity strengthening, capacity building is the process of equipping individuals, a community organization, or an institution to undertake the necessary functions of governance and service provision. For Almanar, it refers both to a relationship and a goal in and of itself. That goal is to empower individuals, communities, and organizations to define and act upon their humanitarian and development priorities while giving them the tools to carry out that goal themselves well into the future.

It is important to note that Almanar does not define or impose "capacity" on an organization or a community. Rather, capacity building is an explicit effort to improve community or organizational performance in relation to its *own* purpose, context, resources, and viability. Our job is to support a process of change whereby people learn to assess their strengths, diagnose key weaknesses, recognize priority issues, and conceive and evaluate actions to address their challenges.

What does capacity development *look like*? Depending on the context, it can involve training, technical assistance (specialist advice in a specific area of expertise), mentoring (accompanying local partners in on the-job experience or skill-sharing), or providing financial support and/or office equipment, transport and other materials.

It is Almanar's programming principle because capacity at different levels of society is necessary so that communities have the tools and know-how to fulfill their own needs. In other words, capacity building is important because Almanar programs will only be truly effective when communities have the knowledge, skills, and abilities to be self-reliant.

### **Partnership**

Partnership is a deliberate alliance with actors similarly motivated to help people survive, recover from and rebuild after conflict and displacement. Almanar partners include community leadership structures, community-based groups and local or international NGOs; state or central government ministries; public service institutions; donors and for-profit agencies.

The key to partnership is that it is not a superficial division of labor whereby each partner pursues his own interests and objectives. Rather, partnership requires parties to have shared goals and joint rights and responsibilities. Partnership can also involve a sharing of human and material resources. Partners are equally powerful and relate to one another with mutual respect and accountability. Characteristics of a successful partnership include effective communication, transparent interaction, and a common understanding of and determination to build upon the value added by those involved.

Why is partnership important? Whether with local or international parties, partnerships allow Almanar to more effectively promote durable solutions by (1) sharing and ultimately facilitating ownership of local actors and (2) building on our own and our partners' comparative advantage so that we all provide expertise effectively without duplication.

### **Holistic Programming**

Holistic programming can be defined as both a programmatic perspective and an approach. Almanar uses community based integrated approach throughout needs assessment, design, implementation, monitoring, and evaluation phases of all its interventions.

Proper integration realizes both **efficiency** through best use of resources and **effectiveness** through better assessment, analysis and addressing problems experienced by target populations. As a perspective, it demands that Almanar incorporates into its planning the many different variables that can influence program implementation and the achievement of objectives. This includes political, social and economic contexts, the relationship between the state, market and civil society, and the resources and relationships that Almanar can bring to bear. As an approach, holistic programming refers to the integration of multiple sectors in any given setting.

**Why is it important for Almanar to focus on holistic programming?** In short, it ensures that we see and address problems with a multidimensional point of view. By concentrating on all aspects rather than one part of a problem, we can better address its root causes and thereby promote durable solutions. Using holistic programming actively as a principle translates into four action steps:

- ***Understanding root causes of conflict in the societies where we work.***

Unless programs take account of and address causes of oppression and violence, Almanar's work will provide only a short-term answer and will not help people move toward durable solutions. More importantly, Almanar's work can have the unintended consequence of contributing to conflict if we lack this kind of understanding.

- ***Understanding the state, market and civil society.***

Although certainly not uniform in every respect, functioning societies are those that manage differences among people, or between the government and citizens through nonviolent, non-oppressive means. Almanar aspires to help war-affected communities reach this point, where people can depend on transparent, predictable, and accountable relationships between the state, market, and civil society.

- ***Ensuring that Almanar programs reflect the needs of, and involve, the whole war-affected community.***

Experience has taught Almanar that targeting specific categories of individuals does not produce sustainable effects and can increase tensions or cause harm. In times of displacement, return, and recovery, Almanar needs to commit to vulnerable and marginalized groups within the context of the larger community

- ***Ensuring that Almanar programs are integrated and coordinated with other key stakeholders.***

To be most effective, Almanar programs need to be integrated so that each sector benefits from each other's strengths. Similarly, Almanar needs to coordinate its work with local and central government, other NGOs (national and international), community groups, and donors.

- **ADVOCACY**

Advocacy must be incorporated in all of Almanar's programming. It seeks to influence decision makers to behave in ways that protect, empower and promote durable solutions for vulnerable and war-affected populations.

### Policies and Regulations

Almanar operations and project implementation are governed by a set of by-laws, constitution and policies approved by the general assembly. Daily activities are governed by sets of different policies, formats, check lists as well as codes of conduct guide as well as a Financial Manual, a Procurement Manual, Warehouse Management Manual, Vehicles Management Manual, and an Asset Management Manual.

### Funding Strategy:

Almanar will ensure that strategy drives funding rather than vice versa. Key to this will be:

- Almanar's Strategic Planning Process.

- Accountability to the strategy: Including grant management mechanisms that check all ideas for proposals and proposals against Almanar strategy
- Clear strategy will allow Almanar to navigate the complex and evolving funding environment and build a funding portfolio to implement our strategy with funding from across the spectrum in Sudan (e.g. national funding, area based funding, sector based funding, emergency and transitional funding)

### **Quality Grant Management:**

The demands of the rapidly evolving funding context in Sudan and the mix of current and targeted funding partners means that a highly effective grants unit and capacity building of staff is essential. Almanar will build the structure, systems and capacity for quality grant management, a key element in the organizational change.

Almanar recognizes that the quality of our funding is as important as quantity to the health of the program and effectiveness of our impact. Almanar will improve the quality of budgeting and financial management to ensure that the successful implementation of programs is not prevented due to the absence of key inputs.

Almanar's improved grant management will include clear roles and responsibilities and capacity building to ensure effective reporting and increase accountability.

Almanar seeks to minimize the administrative burdens of funding partners on program staff. Small grants whose cost in reporting requirements outweighs their programmatic benefits will be avoided, or strategically used to provide crucial match funding or otherwise valuable support costs.

Almanar pursues strategic partnerships with funding partners to support integrated programming and pursue funding for nationwide programs.

### **Data-Driven:**

Almanar's funding is data driven in four ways:

- Strategically targeting and building relationships with funding partners.
- Improved accountability to funding partners via strengthened D, M &E as part of our knowledge management strategy.
- Frequently updated and shared donor mapping (supported by a national, regional and international data gathering system).
- Engage with funding partners' strategies and our analysis of them to guide our own fundraising strategies.

<b>Objectives and results of the action</b>	<p>The overall goal of the project is to contribute in improving the livelihoods status of 210 women (women cooperative members) and their families from among the most disadvantaged communities in IDPs sites in Khartoum through a comprehensive self-reliance, and poverty reduction approach. The project works in an integrated way and combines a comprehensive social development program with activities to increase livelihood opportunities for women, thereby addressing both the causes and effects of women's disempowerment. This will be achieved through building the knowledge and skills of women by raising awareness on their rights, supporting their groups to make their voice heard, providing vocational skills, literacy classes, secured life for their children and communities, and reducing barriers between women from different backgrounds and life experiences in order to contribute in strengthening a base for peace and reconciliation, coupled with gender training for men, leading to an improvement in the socio-economic status of the marginalized women and their families.</p> <p>210 women participated and graduated from the social and economic development, and 100 women completed basic literacy training course. These women have transformed their attitudes and perceptions about gender empowerment, civic education, health, legal issues, leadership skills, teamwork, and conflict resolution. Also, their actions reflect the knowledge and skills acquired during the training sessions.</p> <p>This diverse social development segment of the course increased awareness and open-mindedness, and positively influence the women's perspective on a multitude of issues while increasing their overall effectiveness as educated, aware, and responsible citizens. Furthermore, the economic and basic literacy portions of the training course resulted in 100 women able to assess the country's economic situation and design viable business plans for increased income and livelihood security.</p> <p>In vocational skills, the expected impact is explicit abilities to create consumer products that will sell successfully in the local market and generate profit for the women. The assumption is that these newly acquired skills created profits, increase their income and alleviate the degree of poverty amongst these women, individually and collectively (the numerous established saving groups). The impact also relies on the establishment of self-help saving groups and a microfinance scheme for the loans for the start-up of businesses for 100 women. And the profit has been revolving among the rest of the groups, the other 110 women.</p> <p>Raising awareness among 1500 community members and 200 males is increased knowledge, transformed perceptions and a positive change in attitude and habits towards issues of GBV, gender equality and the treatment of women in their lives. Moreover, more</p>

	<p>understanding has been attained amongst men regarding the importance of a women's role in the family, livelihood support, and capacity to positively influence her family, her community and society.
